

## CHANGE 2 EFFECTIVE MAY 1, 2012

The General Services Administration (GSA) has added a new non-alternating, Agency Specific Code (NAVDD) for the Department of Navy, Navy Supply Systems Command (NAVSUP), Fleet Logistic Centers (FLCs).
