3. Reference Section B, Paragraph B.4 "Application of the Service Contract Act (SCA)" of contract.
 - a. Delete the following (first) sentence: "If a non-exempt labor category is added at the Order level, provided they fall within the scope of the contract and associated Functional Area and NAICS code, it will be incumbent upon the parties to include and abide by the applicable SCA wage determinations in accordance with 41 U.S.C. 358."
4. Reference Section G, Paragraph G.4.a "Delegation of Ordering Authority" of contract.
 - a. Delete the following (first) sentence: "Any General Services Administration, Federal Technology Service Warranted Contracting Officer is authorized to place and administer orders against this contract without a delegation from the Small Business GWAC Center."
 - b. Delete the word "other" in the following (second) sentence: "The GSA Small Business GWAC Center may issue delegated ordering authority, for orders issued against this contract, to all ~~other~~ warranted Government contracting officers in all Federal Government Agencies."
5. Reference Section G, Paragraph G.10 "Subcontracting" of contract.
 - a. In implementing the requirements set forth in 13 CFR 124.510 "What percentage of work must a Participant perform on an 8(a) Contract," change paragraph G.10 to read: "Pursuant to FAR 52.219-14, Limitation on subcontracting, At least 50% of the cost of contract performance incurred for personnel shall be expended for employees of the concern. Contractors shall maintain up-to-date records concerning subcontracting costs and shall submit the standardized report semi-annually (using the contract year) no later than 30 calendar days after each six-month reporting period. The first report period will be the contract notice to proceed date through May 31, 2005.

A separate report shall be completed for each functional area. Report(s) must be submitted every reporting period even if there is no change or no activity on your contract. The completed report shall be submitted to:
