



Hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government.		
WHEREAS, the parties hereto desire to amend the above Lease.		
NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended <u>upon execution by the Government</u> as follows:		
This Supplemental Lease Agreement (SLA) No. 1 is hereby issued to modify Paragraph 1 of the SF-2 for Lease No. GS-11B-02184 to reflect a change in the leased premises and to replace Exhibit A – Floor Plans of the Lease Area with revised plans (attached) reflecting the new demised premises. Paragraph 1 of the SF-2 shall now be replaced in its entirety to read:		
<p style="margin-left: 40px;">The Lessor hereby leases to the Government the following described premises:</p> <p style="margin-left: 40px;">A total of 180,000 BOMA rentable square feet (BRSF) equivalent to 159,033 ANSI/BOMA Office area square feet (ABOA) of office and related space, consisting of a portion of the Fourth (4th) Floor (11,723 BRSF/10,336 ABOA), the entire Fifth (5th) through Ninth (9th) Floors (28,516 BRSF/25,198 ABOA each) and a portion of the Tenth (10th) Floor (25,697 BRSF/22,707 ABOA), being the areas cross hatched on the floor plans attached to this SLA as Exhibit A and made part hereof, as well as 30 reserved parking spaces for Official Government Vehicles as shown on Exhibit B, in the building known as Patriots Plaza II and located at 375 E Street, SW, Washington, DC 20024-3221.</p>		
This document will not constitute a payment obligation until the date of execution by the United States. As a result, even though payments will be made retroactively, no monies whatsoever are due under this agreement until thirty days after the date of execution by the Government's Contracting Officer.		
All other terms and conditions of the lease shall remain in force and effect.
