**WHEREAS**, the parties hereto desire to amend the above Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended as follows:

- I. In a letter dated November 8, 2011, the Government issued a Notice to Proceed ("NTP") for Tenant Improvements ("TI") in the amount of \$818,586.41. The Government hereby orders the balance of the TI in the amount of \$683,006.82.
- II. The Government shall reimburse the Lessor in a lump sum payment in the amount of \$683,006.82, upon receipt of an original invoice after completion, inspection, and acceptance of the space by the Contracting Officer.
