THIS LEASE, made and entered into this date between City and County of San Francisco, acting by and through its Airport Commission, c/o the Airport Director, San Francisco International Airport

and whose interest in the property hereinafter described is that of OWNER, hereinafter called the LESSOR, and the UNITED STATES OF AMERICA, hereinafter called the GOVERNMENT:

WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:
2,612 rentable square feet (rsf)/usable square feet (usf) of office space and related space located on the 1st Floor of Terminal 3 (Suite T3.1.063) as depicted on the attached (Exhibit "A") (the "Premises"), to be used for administrative offices for the U.S. Drug Enforcement Administration, and SUCH PURPOSES AS DETERMINED BY THE GENERAL SERVICES ADMINISTRATION.
2. PARAGRAPH 2 IS INTENTIONALLY OMITTED.
3. PARAGRAPH 3 IS INTENTIONALLY OMITTED.
4. The Government may terminate this lease in whole or in part at any time after the third (3rd) year of this lease by giving at least one hundred twenty (120) days' prior notice in writing to the Lessor. No rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.
5. PARAGRAPH 5 IS INTENTIONALLY OMITTED.
6. The Lessor shall furnish to the Government as part of the rental consideration, the following:
 - A. Eight (8) onsite structured parking space(s).
