



## How to use the Janitorial and Sanitation Supplies Purchasing Channel

Federal agencies now have a fast and effective way to purchase janitorial and sanitation supplies at notably discounted prices. The government-wide Janitorial and Sanitation (JanSan) supplies strategic sourcing solution offers an opportunity for notable savings by federal agencies. Average purchase channel prices are 27 percent lower than what is currently found within the federal government marketplace. **Meet your small business goals with 15 small business vendors, including five (5) Service-Disabled, Veteran Owned Small Businesses.**

In order to streamline the product catalog and ensure lower prices, GSA has grouped JanSan products into four categories: *Cleaning Compounds and Related Dispensers, Non-Motorized Cleaning Equipment and Trash Receptacles, Paper Products and Related Dispensers, and Motorized Floor Cleaning Equipment and Accessories.* Within the four categories, a broad range of products are available, including disinfectants, degreasers, glass cleaners, laundry and dish detergents, bleach, hand soaps and sanitizers, brooms, mops, brushes, trash receptacles and bags, toilet paper, paper towels, facial tissues, seat liners, vacuum cleaners, wet/dry vacs, floor buffers, polishers and burnishers. In addition to better pricing, GSA has made the *process* of buying janitorial products easier. There is less product duplication and, by streamlining the number of contractors, comparison shopping will be simpler. Plus, direct delivery will make shipping more prompt and cost-effective. To help you meet sustainability goals, GSA has also included bio-based products and products that are made with recovered materials.

### Purchasing options

#### Direct ordering from contractors

Agencies can order direct from the JanSan contractor websites, by phone or fax, and at retail store locations with a GSA SmartPay2<sup>®</sup> or government purchase card. The blanket purchase agreements (BPAs) have a \$100 minimum purchase requirement. If an order totals less than \$100, some contractors may impose a service fee on that order. *See Contractor Information table on reverse to find a listing of ordering information and applicable ordering fees.*

#### GSA Advantage!<sup>®</sup>

Through [www.gsaadvantage.gov](http://www.gsaadvantage.gov), agencies have access to the wide range of janitorial and sanitation supplies under the JanSan purchase channel BPAs. Customers will receive BPA pricing by placing orders directly through GSA Advantage!<sup>®</sup> using their GSA SmartPay2<sup>®</sup> or government purchase card, and orders will be shipped direct to the buyer. Orders totaling less than \$100 or using expedited shipping must be placed directly with the contractor.

#### U.S. Department of Defense FedMall

The JanSan purchase channel BPA pricing is also available through the U.S. Department of Defense's FedMall. Orders totaling less than \$100 must be placed directly with the contractor.

#### ReverseAuctions<sup>SM</sup> through GSA eBuy

With ReverseAuctions<sup>SM</sup>, JanSan contractors compete one-on-one for agency business. Through [www.reverseauctions.gsa.gov](http://www.reverseauctions.gsa.gov), authorized ordering activity personnel submit a solicitation, then contractors under the JanSan purchase channel BPAs can submit bids that compete off of each other's submitted pricing.

An award can then be made to the lowest bidder if it meets the solicitation's terms and conditions and is technically acceptable. Ordering activity personnel will need a valid GSA eBuy user name and password to use this site.
