- At the end of each calendar year, GSA board members review each industry member's performance to ensure contributions remain consistent with the QPC Charter. If contributions are lacking, the council will suggest improvements. Additionally, if an industry board member can no longer serve, he can relinquish his position.
- Vacant positions can remain vacant until an upcoming election or a replacement can be made by appointing a candidate from the most recent election.

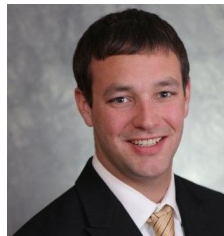
