WHEREAS, the parties hereto desire to amend the above Lease to issue a Notice to Proceed for Change Order #16, #17 and #18 for a total amount of \$18,132.84.

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution of the Government as follows:

I. As recently negotiated, the Government approves the change orders as described below. The anticipated date of completion of all the tenant improvements shall remain the same.

- Change Order #16 -- Install TVM foil at the floor and solid core Matrix underlayment at room 6 and 14. Provide and install TVM foil over structural glue lam beams to the bottom of the rafters. Box out structural hardware with 5/8" gypsum board and fire tape- [REDACTED]
- Change Order #17 -- 1) At room 4a, add one 3/4" conduit for printer data
2) At room 14, install one dedicated circuit with 3 receptacles for printers and two 3/4" conduits for data - [REDACTED]
- Change Order #18 -- 1) Add one dedicated circuit and two data conduits in room 7.2
2) Add two 3/4" data conduits at room 7.3
3) Add receptacle and one 3/4" data conduit in room 8
4) Relocate circuit C-1 26 to printer location - [REDACTED]

Total: \$18,132.84

If the invoice is not submitted on company letterhead, the person(s) with whom the Lease contract is made must sign it.

- III. The Lessor hereby waives restoration as a result of all improvements. Unless the Government has removed such items from the premises, the Lessor shall repair and maintain such items provided by the Lessor in accordance with this Lease Agreement GS-09B-02973. If, after the lease term or any extensions, or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor.

All other terms and conditions of the lease shall remain in force and effect.
