**WHEREAS**, the parties hereto desire to amend the above Lease. The purpose of this Lease Amendment is to issue the Notice to Proceed, and provide invoice and payment instructions for the Post Occupancy alterations described below..

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended as follows:

The purpose of this Lease Amendment (LA) is to provide the funds necessary to complete post-occupancy alterations to address mechanical issues identified after occupancy. These alterations are for the installation of an additional VAV box as well as a thermostat for the 8,611 RSF, for a lump sum payment of \$12,000, once the work has been inspected and accepted by the General Services Administration.


Payment is contingent upon receipt of a proper invoice, which shall include:
