hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

The purpose of this Amendment is to accept the Space and Rent Commencement and establish the effective date of termination rights in the Lease.

WHEREAS, the parties hereto desire to delete the **LEASE TERM** and **TERMINATION RIGHTS** paragraphs in their entirety and replaced by the following, similarly titled paragraphs in lieu thereof:

NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective **April 01, 2014** as follows:

LEASE TERM

To Have and To Hold the said Premises with its appurtenances for the term beginning on **April 1, 2014** and continuing through **March 31, 2021**, subject to termination and renewal rights as may be hereinafter set forth.

PARAGRAPH 1.05, 'TERMINATION RIGHTS' SHALL BE DELETED IN ITS ENTIRETY AND REPLACED WITH THE FOLLOWING PARAGRAPH 1.05:

1.05 TERMINATION RIGHTS

The Government may terminate this Lease, in whole or in part, at any time effective after **March 31, 2017**, by providing not less than ninety (90) days' written notice to the Lessor. The effective date of the termination shall be the day following the expiration of the required notice period or the termination date set forth in the notice, whichever is later. No rental shall accrue after the effective date of termination.
