hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, **April 2, 2012**, as follows:

**Supplemental Lease Agreement (SLA) No. 5 to Lease GS-05B-18418**, are hereby issued to remove paragraphs Section 1.2 Unique Requirements, Section 8.5 Drinking Fountain and Section 8.6 Toilet Rooms (2)(i) from the requirements of the lease. Section 8.6 Toilet Rooms (2)(e) will be replaced.

**Paragraphs 1.2 Unique Requirements (T), 8.5 Drinking Fountain and Section 8.6 Toilet Rooms 2i are hereby deleted in their entirety:**

- 1.2 Unique Requirements (T)** - A vestibule is required for any entrance into the space that leads directly from the outside. Self closing doors must be provided. This vestibule shall not be included in the usable measurement of the space.
- 8.5 Drinking Fountain -** The Lessor shall provide, on each floor of Government occupied space, a minimum of one chilled accessible drinking fountain with potable water within every 200 feet of travel.
- 8.6 Toilet Rooms (2)(i) -** a floor drain

**Paragraph 8.6 Toilet Rooms (2)(e) is hereby deleted in its entirety and replaced with:**

(e) The Lessor shall provide and stock the feminine products (sanitary napkins and tampons) in the wall cabinet in the womens restroom.

All other terms and conditions of the lease shall remain in force and effect.
