WHEREAS this Notice to Proceed is issued for the NOT EXCEED amount of \$16,679.00 in accordance with the specifications detailed in Exhibit A (Change Order Proposals 28, and 29), attached hereto and made a part hereof. Please be advised that any work that is done that exceeds the cost specified above will be the financial responsibility of the Lessor. At the request of the Government, the Lessor shall provide all labor, materials and equipment to install the following Change Order: C.O.P. NO. 28: Dedicated 30amp Receptacle in IT Rooms (C.O.P. dated 03/18/11) \$ [REDACTED] Total C.O.P. NO. 29: Sleeves in First Floor IT Rooms (C.O.P. dated 03/18/11) \$ [REDACTED] Total Lessor will be paid a lump sum payment in the amount of \$16,679.00 after completion of the work and acceptance by the Government. Payment will be due only for items which are stated above. Lessor waives any restoration in connection with these items. Lessor shall remain responsible for maintenance, repair and replacement of all items provided by the Lessor under this lease.
