

- 1) To restate the square footage of the Premises and parking spaces; and





1.) The Premises are described as follows: 4,033 rentable square feet (RSF), yielding 3,500 ANSI/BOMA Office Area (ABOA) square feet (SF) of office and related space based upon a common area factor of 15.24 percent, located on the 2nd floor. Also included in the Lease are 3 total on-site surface parking spaces. In addition, the Lessor shall provide such additional parking spaces as required by the applicable code of the local government entity having jurisdiction over the Property.

2.) TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on July 16, 2014 and continuing for a period of 10 years, expiring July 15, 2024, subject to termination and renewal rights as may be hereinafter set forth, to be used for such purposes as determined by GSA.

3.) The Government shall pay the Lessor annual rent, payable in monthly installments in arrears, at the following rates:

4.) The Government may terminate this Lease, in whole or in part, at any time, effective after the firm term of this Lease, July 15, 2019 by providing not less than 90 days' prior written notice to the Lessor. The effective date of the termination shall be the day following the expiration of the required notice period or the termination date set forth in the notice, whichever is later. No rental shall accrue after the effective date of termination.

5.) Section 1.04 of the Lease, **BROKER COMMISSION AND COMMISSION CREDIT (JUN 2012)**, is confirmed as follows:

A. Savills Studley, Inc. (f/k/a Studley, Inc.) (Broker) is the authorized real estate Broker representing GSA in connection with this Lease transaction. The total amount of the Commission is [REDACTED] and is earned upon Lease execution, payable according to the Commission Agreement signed between the two parties. Only [REDACTED] of the Commission will be payable to Savills Studley, Inc. with the remaining [REDACTED], which is the Commission Credit, to be credited to the shell rental portion of the annual rental payments due and owing to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue until the credit has been fully recaptured in equal monthly installments over the shortest time practicable.

B. Notwithstanding the "Rent and Other Consideration" paragraph of this Lease, the shell rental payments due and owing under this Lease shall be reduced to recapture fully this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue as indicated in this schedule for adjusted Monthly Rent:

Month 1 Rental Payment \$9,180.71 minus prorated Commission Credit of [REDACTED] equals [REDACTED] adjusted 1st Month's Rent.

Month 2 Rental Payment \$9,180.71 minus prorated Commission Credit of [REDACTED] equals [REDACTED] adjusted 2nd Month's Rent.

Month 3 Rental Payment \$9,180.71 minus prorated Commission Credit of [REDACTED] equals [REDACTED] adjusted 3rd Month's Rent.

6.) All other terms and conditions of this lease shall remain in full force and effect.
