**WHEREAS**, the parties hereto desire to amend the above Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said lease is amended, effective upon execution by the Government as follows. The purpose of Supplemental Lease Agreement (SLA) No. 5 is to issue Notice To Proceed on the requested change orders in accordance with Exhibit A (14 pages), attached and made part of this lease.

1. The following changes are made in accordance with the changes clause of the General Clauses of the lease, section 552.270-14(2), Works and Services:

- 1. Change Order #9 – Furnish and install peep holes in 14 hearing rooms: [REDACTED]
- 2. Change Order #10 – Install one power and one data (ring & string) to HOCALI and VSD hearing rooms: [REDACTED]
- 3. Change Order #11 – Install keypad at stairwells and coordinate fire alarm testing: [REDACTED]
- 4. Change Order #12 – Add 24 CAT 6 and reterminate cables in MDF: [REDACTED]
- 5. Change Order #13 – Add D-Mark extension: [REDACTED]
- 6. Change Order #14 – Disconnect power poles to furniture; make power pole j-box code compliant: [REDACTED]
