WHEREAS, the parties hereto desire to amend the above Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said lease is amended, effective upon execution by the Government, as follows:

The purpose of this Lease Amendment (LA) 3 is to reflect additional cost for worked provided for in LA 1 and maintenance of alterations.

1. The purpose of LA 3 is to provide for an additional \$1,280.10 for a bond fee related to the alterations provided for in LA 1.
2. The lessor will maintain the alterations provided for in LA 1 and LA 3. The Lessor hereby waives all rights to restoration pertaining to these alterations.
3. All work will be completed within 90 days of Notice to Proceed. Work will be coordinated with Steve Bishop at 210-306-2950.
