**WHEREAS**, the parties hereto desire to amend the above Lease to: (i) establish the Government's acceptance of the premises as substantially complete; and (ii) establish the lease and rent commencement date.

**NOW THEREFORE**, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective UPON EXECUTION as follows:

- A. The Government hereby accepts the tenant improvement build out to Suite 225S as set forth in the Lease as substantially complete effective August 23, 2016. Accordingly, the Lease is hereby amended to establish a lease and rent commencement date of August 23, 2016. The expiration date of the Lease is hereby established to be August 22, 2021, notwithstanding any Government renewal rights defined in Lease paragraph 1.06.
- B. The Government shall reconcile all outstanding amounts due and payable by the Government through the execution date of this Lease Amendment. Payment shall be made in accordance with the "Prompt Payment" clause of the General Clauses, which is Exhibit E to the Lease.




