WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective August 2, 2012, as follows:

1. The Lessor shall supply all labor and materials to accomplish as set forth and contained in the attached Exhibit A in Supplemental Lease Agreement # 6 attached hereto and made a part hereof. All work shall be coordinated with Alan Bombardier, Construction Control Representative. Work is to be completed no later than October 1, 2012.
2. Upon completion of this work and approval of the same by the Government, the Government shall pay the Lessor \$7,314.00 in full consideration for this work performed. Request for payment shall be made by a submission of an invoice upon completion. Payment will be made within 30 days after receipt of the invoice and the inspection and acceptance of the work by the Government. Progress payments will not be allowed on this project.
3. NONPAYMENT FOR ADDITIONAL WORK: Any additional supplies or services or a change to work specified herein may be performed by the contractor, either at his/her own volition or at the request of an individual rather than a duly appointed Contracting Officer, except as may be explicitly authorized and will not be paid for. Only a duly appointed Contracting Officer is authorized to change the specifications, terms and conditions in this contract.

All other terms and conditions of the lease shall remain in force and effect.
