WHEREAS, the parties hereto desire to amend the above Lease to order tenant improvements which exceed the tenant improvement allowance.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective March 31, 2010, as follows:

1. On March 5, 2010 the Government issued a Notice to Proceed in the amount of \$152,235.47, for the total cost of Tenant Improvements. In separate correspondence dated March 31, 2010, and April 1, 2010 the Government received Change Order #1 in the amount of \$2,643.33, and Change Order #2 in the amount of \$3,004.68, as part of the Tenant Improvements of this lease. These change orders were not incorporated in the TI reconciliation done in SLA#1 and therefore are incorporated through this SLA. The Government hereby orders the additional balance of \$5,648.01 to be paid via lump sum.

II. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$5,648.01. Payment shall be made within 30 days after receipt of an invoice and the above stated completion and acceptance requirements.
