NOW THEREFORE, these parties for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, covenant and agree that the said Lease is amended, effective upon execution:

Paragraph 27 is hereby added to the Lease:

"27.) The Tenant Improvement costs have increased by the amount of [REDACTED] as a result of Change Order Request (COR) numbers 1, 2, 3, 4, and 6. The Tenant Improvement cost includes all the Lessor's fees for general and administrative costs, profit and any and all other fees associated with the completion of the Tenant Improvements. 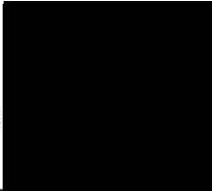

Total Tenant Improvement Cost: \$ 589,483.38

The revised total cost for Tenant Improvements, in the amount of \$589,483.38, exceeds the tenant improvement allowance of \$518,061.72, which has been amortized into the rental rate. The Government hereby orders the excess balance in the amount of \$71,421.66. The Lessor shall construct all Tenant Improvements in accordance with the Solicitation for Offers, incorporated and made a part of the lease, and all terms and conditions of the lease package. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$71,421.66 pursuant to Paragraph 27 of this Lease."

To submit for payment of the lump-sum-payment, the Lessor agrees that the invoice shall be printed on the same letterhead as the named on this lease, shall include the Lease number, building address, and a price and quantity of the items delivered. **The invoice shall reference the number PDN PS0026879** and shall be sent electronically to the GSA Finance Website at <http://www.finance.gsa.gov/defaultexternal.asp> .
