NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective upon execution by the Government as follows

This Lease Amendment represents your Notice to Proceed (NTP) with the construction of the Tenant Improvements in the amount of \$470,526.56. Of the \$470,526.56 Tenant Improvement Costs, only \$392,184.80 are amortized into the rent for five (5) years at a rate of 6.0% per annum as described in the Lease. The remaining balance of \$78,341.76 shall be paid to the Lessor upon completion as described herein. The Lease requires completion of the construction not later than 90 working days following issuance of the Notice To Proceed.

1. Upon completion, inspection, and acceptance of the work, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$78,341.76, upon receipt of an original invoice after completion, inspection, and acceptance of the work by the Lease Contracting Officer.


