Upon execution of this Lease Amendment (LA) by the Contracting Officer, this Amendment serves as a Notice to Proceed (NTP) for alterations.

1. NOTICE TO PROCEED

This Lease Amendment serves as a Notice to Proceed with alterations, as detailed in the attached Scope of Work (SOW), in the amount of \$11,181.50. This amount will be paid in a one-time lump sum to the Lessor upon completion, inspection and acceptance of the work and receipt of an invoice or invoices for the work, by the Government.




Be advised that any work that is done that exceeds the costs specified above will be the financial responsibility of the Lessor. In accordance with the Lease, the Lessor shall complete all work within thirty (30)-calendar days of execution of this Notice to Proceed.

The occupying tenant-agency does not have the contractual authority to enter into any agreements with the Lessor or the Lessor's representative(s) for alterations, changes or modifications of this Lease unless, approved by a GSA Contracting Officer. To enter into such agreements with the occupying tenant-agency may result in unrecoverable costs for the Lessor.




