- Function (or continue to function) as a Veteran Small Business Advocate internally among GSA's workforce and leadership for VOSBs and SDVOSBs
- Actively participate and encourage participation in agency-wide collaboration activities (e.g., online collaboration events and ongoing discussion blogs on Interact.gov)
- Help launch GSA's Veteran Business Community of Interest and conduct or participate in periodic webinar training, Q&A, etc., for this group
