What is a GWAC?

A Governmentwide Acquisition Contract is defined as a task or delivery order contract for *information technology*.

- Contracts established by one agency for governmentwide use
- Operated by an Executive Agency designated by the OMB
- Pursuant to Section 5112(e) of the Clinger-Cohen Act

Alliant Basic Contract Scope

➤ General

- Information Technology (IT) Services and IT Services-based Solutions Contract aligned with FEA/DoDEA
- Robust scope that provides access to a range of complementary management, technical, and other support services
- IT Services-based solutions may include ancillary non-IT components as long as they are integral and necessary to accomplishing the IT solution

Alliant Ordering

Accessing the Alliant GWACs

- **Delegation of Procurement Authority (DPA)**
 - GWAC office provides training and issues DPA
 - Agency contracting shop conducts acquisition and task order administration
 - Fee of 0.75% included in contractor labor rates
- **Interagency assisting entities**
 - Third-party conducts acquisition
 - Fees negotiated between customer agency and assisted services organization
