## Eco-Healthy Child Care

### Plastics & Plastic Toys

Certain plastics are known to contain toxins which have negative impacts on human health. Children are particularly vulnerable to toxins since their immune systems and organs are still developing. Young children are also at greater risk since they often insert plastic objects into their mouths. Baby bottles, sippy cups, teething rings, and toys are often made with phthalates and Bisphenol-A (BPA). These two toxic ingredients in plastics are of particular concern, as research increasingly shows that these chemicals mimic hormones and disrupt normal development and growth.

#### 7 Tips for Safer Use of Plastics:

1. Avoid plastics with recycling code #3, #6, and #7.
2. Do not heat or microwave food in plastic containers, as leaching of toxic chemicals from plastic to food or liquid may occur.
3. Use PVC-free plastic wrap (buy plastic wrap and bags made with polyethylene).
4. Minimize the use of canned foods and canned drinks.
5. Choose phthalate-free toys. Look for toys labeled "phthalate-free" or "PVCfree". Choose toys made from polypropylene or polyethylene, or avoid plastic toys altogether.
6. Purchase phthalate-free beauty products.
7. Ask your dentist for BPA-free sealants and composite fillings.

Eco-Healthy Child Care is a national program created by the Oregon Environmental Council to ensure that child care settings are as healthy, safe and green as possible by reducing children's exposure to toxins. GSA is proud to partner with the Oregon Environmental Council in support of child care centers going green.

Congratulations & thank you to all for helping us achieve our first goal. Nationally, GSA centers are now 51% Eco-Healthy endorsed. Our goal was 50% by March 1.
