


AbilityOne creating Opportunities for Americans with Disabilities

Sponsored by Senator Robert Wagner and Representative Caroline O'Day, in 1938 President Roosevelt signed into law the Wagner O'Day act that mandated the federal Government purchase brooms, mops and other suitable commodities furnished by non Profit agencies employing people who are blind.

In 1971, Senator Jacob Javitz was successful in having the law amended to include People with severe disabilities and the addition of providing services to the federal Government.

Our Mission:


To enhance opportunities for economic and personal independence of persons who are blind or severely disabled primarily through creating, sustaining and improving employment.



(ETS) Essentially The Same
