**THIS AGREEMENT**, made and entered into this date by and between **MICHAEL SLATTERY**

whose address is [REDACTED]

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease to order and pay lump sum for tenant improvements over and above those authorized and approved under the Lease.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective May 25, 2011, as follows:

- I. In a separate document (SLA#1 dated March 1, 2011) the Government approved a total of \$57,942.72, of which \$10,000.00 is included in the Gross Rent offered by the Lessor. The remaining \$47,942.72 is being amortized into the Lease at 7.5% annual interest. Pursuant to the attached Proposal from the Lessor, dated April 12, 2011, and May 5, 2011, GSA hereby orders additional TIs in the amount of \$18,485.00, for CAT 6 data cabling and roof wall construction, to be paid via lump sum.
- II. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a lump sum payment in the amount of \$18,485.00. Payment shall be made within 30 days after receipt of an invoice and the above stated completion and acceptance requirements.






