**THIS AGREEMENT**, made and entered into this date by and between **HTGP&B Investments '81**, whose address is 590 University Avenue, Fairbanks, AK 99709-3641,

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease to commence a data port installation project.

**NOW THEREFORE**, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective May 2, 2011, as follows:

Supplemental Lease Agreement Number 1 is issued to amend lease GS-10B-07253 dated April 5, 2011 and commence a data port installation project.

Project: The Lessor shall install eight CAT five data lines as specified in Exhibit A "Scope & Price Proposal". The lines shall be connected, terminated, tested, and certified.

Warranty: The Lessor shall warranty the tenant improvements for one year and shall maintain the tenant improvements in accordance with GSA Form L-210A to GS-10B-07253 and SFO 7AK2189 as last amended.



Restoration: The Lessor waives any and all rights of restoration against the Government concerning tenant improvements completed with this Supplemental Lease Agreement. At the Lessor's expense, the Lessor shall restore to original condition anything damaged by the work performed.

Site Conditions: The Lessor shall maintain worksite conditions in accordance with standard OSHA requirements. The Lessor shall prevent injuries to individuals conducting business in and adjacent to the work area.

Acceptance: The Lessor shall request a final inspection upon project completion. Upon receipt of the request, an appointed GSA Contracting Officer Representative shall inspect the worksite within 10 working days and shall inform the Lessor of acceptance of the tenant improvements or actions required to gain acceptance.
