THIS AGREEMENT, made and entered into this date by and between Rainier Capital, through GSA LeaseCo, LLC whose address is 13760 Noel Road, Suite 800 Dallas, TX 75240

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease contract as follows:

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective June 10, 2010, as follows:

This Supplemental Lease Agreement (SLA) No. 44 has been prepared in issue acceptance and Notice to Proceed of the Lessor's proposals, indicated in Exhibit "A" attached to this SLA, in the total amount of [redacted] for the following 2nd Floor Area Lighting. The IGE's have been reviewed and the cost has been determined to be fair and reasonable.

Payment will be due only for items which are listed in the Scope of Work, Exhibit "A" attached to this SLA or requested in writing by the Contracting Officer.

The Lessor will be issued a lump sum payment upon completion, inspection and acceptance of the Scope of Work by the Government. Payment is predicated on receipt of this signed SLA and a certified invoice at the time of work completion. All invoices shall be sent to: U. S. General Services Administration, Finance Division - 7BCF, 819 Taylor Street, Fort Worth, Texas 76102-0181. The Payment Instrument Code Nos. are PS 0018026 in the amount [redacted] must be included with payment submits. Upon said payment, all removable non-structural fixtures shall become the property of the Government and may be changed, relocated and/or removed from the leased premises by the Government.

The Lessor hereby waives of restoration for all areas affected by this installation.

Except as modified in this Agreement, all terms and conditions of the Lease shall remain in full force and effect, and in the event that any of the terms and conditions of this Agreement conflict with any terms and conditions of the Lease or any previous supplemental lease agreements, the terms and conditions of this Agreement shall control and govern.

This SLA NO. 44 specifically excludes any material in operating expense associated with the work being performed and is subject to no operating cost increase to be agreed upon by Lessor & the Government.
