SUPPLEMENTAL LEASE AGREEMENT

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective November 30th, 2011 to issue the notice to proceed with the construction of the demised premises, as follows:

The lease is amended as follows:

Upon execution of this Supplemental Lease Agreement (SLA), this serves as a Notice to Proceed (NTP) for the construction of tenant improvements.

This Notice to Proceed is issued to NOT EXCEED the amount of \$17,886.00 in accordance with the estimate provided. And approved change orders #9, #4, #5, #13, #14, #15, #17, #19, #8, #1, #24, #23 and #18R.

Upon execution of this Supplemental Lease Agreement, the total tenant improvement amount obligated is \$839,521.08.

The occupying tenant agency does not have the contractual authority to enter into any agreements with the Lessor or the Lessor's representatives for improvements, changes or modifications of this lease agreement unless, approved by a GSA, Contracting Officer. To enter into such agreements with the occupying tenant agency may result in unrecoverable costs for the Lessor.

The Lessor waives all restoration rights.

Except as modified in this Agreement, all terms and conditions of the Lease shall remain in full force and effect, and in the event that any of the terms and conditions of this Agreement conflict with any terms and conditions of the Lease or any previous supplemental lease agreements, the terms and conditions of this Agreement shall control and govern.
