

**US GOVERNMENT
LEASE FOR REAL PROPERTY**

DATE OF LEASE June 18, 2012.

THIS LEASE, made and entered into this date by and between **CF Properties, LLC**

Whose address is **300 Market Street, NE, Suite 3
Decatur, AL 35601-7806**

and whose interest in the property hereinafter described is that of **OWNER**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 9,768 rentable square feet (RSF), consisting of 9,164 ANSI/BOMA Office Area Square Feet (ABOASF) of office and related space on the first floor of a one story building, plus fifty-eight parking spaces (55 on site and 3 on an adjacent lot, located at 717 McGathery Lane, Morgan County, Decatur, AL 35601-3054

to be used for **SUCH PURPOSES AS DETERMINED BY THE GENERAL SERVICES ADMINISTRATION**

2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on March 16, 2013 through March 15, 2023 subject to

termination and renewal rights as may be hereafter set forth.

3. The Government shall pay the Lessor annual rent for the entire term, monthly, in arrears, as follows:

Note 1. The rate per rentable square foot (RSF) is determined by dividing the total annual rental by the rentable square footage set forth in Paragraph 1 above.

Note 2. The rate per ABOASF is determined by dividing the total annual rental by the ABOASF set forth in Paragraph 9.

4. The Government may terminate this lease, in whole, at any time on or after the first day of the eleventh (11th) full lease year after the lease commencement date, by giving the Lessor at lease ninety (90) days notice in writing. No rent shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.

5. The Government has one (1) 5 year renewal option for this lease. Effective 03/16/2023 Rate: \$20.87 PRSF or \$203,858.16 p/a

6. Rental is subject to the Government's measurement of plans submitted by the Lessor or a mutual on-site measurement of the space and will be based on the rate per ABOASF as noted in Paragraph 3 above, in accordance with Clause 27 (PAYMENT), GSA Form 3517B, General Clauses. The lease contract and the amount of rent will be adjusted accordingly, but not to exceed the maximum ABOASF requested in SFO Paragraph 1.1 (Amount and Type of Space). Rent for a lesser period shall be prorated. Rent checks shall be made payable to:




- 7. The Lessor shall furnish to the Government, as part of the rental consideration, the following:
 - A. Those facilities, services, supplies, utilities, and maintenance in accordance with Solicitation for Offers (SFO) No. 0AL2022.
 - B. Buildout in accordance with SFO No. 0AL2022. Design Intent Drawings (DIDs) shall be prepared by the Tenant Agency and due to the Lessor within one hundred – twenty (120) working days subsequent to lease award. All tenant alterations are to be completed within one-hundred twenty (120) calendar days of receiving notice to proceed from the Government with agency approved working/construction drawings. Lease term to be effective and rental to begin on date of occupancy, if different from Paragraph 2.
 - C. Deviations to the approved DIDs furnished by the Lessor to the Government and reviewed/approved by the Government subsequent to award will not be permitted unless prior written authorization is obtained from the GSA Contracting Officer.
 - D. Lessor shall provide fifty eight (55 on site and 3 on adjacent lot) on-site parking spaces. The cost of parking is at no additional cost.



9. The premises described in Paragraph 1 of this Standard Form 2 shall contain 9,164 ABOASF of office and related space, as identified in SFO No. 0AL2022. The rental rate in Paragraph 3 of this Standard Form 2 for the period 12/15/12 through 12/14/17 includes all Tenant Improvements (TI). In accordance with Paragraph 1.10 (Tenant Improvements Included In Offer) of SFO No. 0AL2022, the TI allowance provided in the lease is \$36.613080 per ANSI/BOMA Office Area square foot for 9,164 ABOASF is \$335,522.27 [REDACTED] shall be separated when obtaining T/I bids) amortized at an interest rate of 5% over five (5) years yielding an annual cost of \$75,980.63 at a rate of \$7.78 per RSF (\$8.29 per ABOASF). The TI allowance will be used to construct the interior space in accordance with the approved DIDs provided by the Lessor. If the TI cost exceeds \$36.613080 per ABOASF (for up to 9,164 ABOASF), the balance due the Lessor will be paid by rental adjustment or lump sum, to be determined by the Government. If the entire TI allowance of \$36.613080 per ABOASF is not used, the Government will adjust the rental rate downward to off-set the difference. The Lessor understands, in lieu of Cost and Pricing Data, his contractor or each of his sub-contractors shall solicit a minimum of two (2) bids for work completed as a part of the initial tenant alterations, e.g., for electrical, plumbing, etc. The lowest responsive bid will be accepted. This does not apply to the shell build-out.
11. In accordance with Paragraph 1.9 (Building Shell Requirements) of SFO No. 0AL2022, the annual shell cost is established as \$136,375.69 yielding \$13.96 per RSF (\$14.88 per ABOASF) which is inclusive of the rental rate in Paragraph 3 for the period 03/16/2013 through 03/15/2023.
12. In accordance with Paragraph 3.3 (Tax Adjustment) of SFO No. 0AL2022, the percentage of Government occupancy is established as 100% (based on total building area of 9,768 RSF and the Government's occupancy of approximately 9,768 RSF). Percentage of occupancy is subject to revision based on actual measurement of Government occupied space at time of final inspection, not to exceed the maximum ABOASF stated in the SFO, and in accordance with GSA Form 3517B, GENERAL CLAUSES.
13. In accordance with Paragraphs 3.5 (Operating Costs) and 3.6 (Operating Costs Base) of SFO No. 0AL2022, the annual operating cost is established as \$47,472.48 yielding an escalation base of \$4.86 per RSF (\$5.18 per ABOASF) which is included in the rental rate in Paragraph 3 for the period 03/16/2013 through 03/15/2023.
14. In accordance with Paragraph 3.9 (Common Area Factor) of SFO No. 0AL2022, the common area factor (CAF) is established as 6.59%, based on 9,768 RSF and 9,164 ABOASF.

23. In accordance with SFO No. 0AL2022, Paragraph 1.13, the Lessor and the Broker have agreed to a cooperating lease commission of [REDACTED] of the firm term value of this lease. The total amount of the commission is [REDACTED]. The Lessor shall pay the Broker no additional commissions associated with this lease transaction. In accordance with the "Broker Commission and Commission Credit" paragraph, the Broker has agreed to forego [REDACTED] of the commission that it is entitled to receive in connection with this lease transaction ("Commission Credit"). The Commission Credit is [REDACTED]. The Lessor agrees to pay the Commission less the Commission Credit to the Broker in accordance with the "Broker Commission and Commission Credit" paragraph in the SFO attached to and forming a part of this lease. The [REDACTED] balance which equates to [REDACTED] is to be paid to the broker as follows: One-hundred percent (100%) is due and payable within 30 days after lease award. Notwithstanding Paragraph 3 of this Standard Form 2, the shell rental payments due and owing under this lease shall be reduced to fully recapture this Commission Credit. The reduction in shell rent shall commence with the first month of the rental payments and continue as indicated in this schedule for adjusted monthly rent.

First Month's Rental Payment of \$21,652.40 minus the prorated Commission Credit of [REDACTED] equals the adjusted First Month's Rent of [REDACTED].

Second Month's Rental Payment of \$21,652.40 minus the prorated Commission Credit of [REDACTED] equals the adjusted Second Month's Rent of [REDACTED].

Third Month's Rental Payment of \$21,652.40 minus the prorated Commission Credit of [REDACTED] equals the adjusted Third Month's Rent of [REDACTED].
