


**1.) Commencement Date of Lease Rental Payments**

The total term of the lease agreement is ten (10) years. The commencement date of the rental shall begin on April 1<sup>st</sup>, 2012 and shall expire on March 31<sup>st</sup>, 2022.

**2.) Rental Payment Schedule**

The Government shall pay the Lessor annual rent as follows:

To have and to hold the leased premises with their appurtenances for the term beginning on April 1, 2012 and continuing through March 31, 2017 inclusive, the total annual rental shall be \$43,612.58 paid monthly in arrears, subject to termination rights stated within the lease. The total annual rent consists of Shell Rent of \$37,403.74 and annual Operating Costs of \$6,208.84.

To have and to hold the leased premises with their appurtenances for the term from April 1, 2017 through March 31, 2022 the total annual rental shall be \$45,842.94 paid monthly in arrears, subject to termination rights stated within the lease. The total annual rent consists of Shell Rent of \$39,317.63 and annual Operating Costs of \$6,525.31.

**3.) Percentage of Occupancy**

The Government's percentage of occupancy is 2.898% [1,507 / 52,000 X 100].

**4.) All other terms and conditions are in full force and effect.**
