WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said lease is amended, effective on the day the Government signs Supplemental Lease Agreement Number 21, as follows:

Paragraph Number **55** is hereby added to the lease contract as follows:

55. The Lessor shall provide all labor, materials, professional design fees and permits to furnish, install and maintain all changes identified in Tenant Work Request (TWR) Number 33, 50, 51, 54, 62 and 63; which will be deducted from the remaining credit deduction from resolution of Debits and Credits and the remaining balance will be paid via a Lumpsum to the Lessor:
