hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective on the day the Government signs **Supplement Lease Agreement Number 19** as follows:

Supplemental Lease Agreement Number 19 is hereby issued to reflect a Lumpsum payment to the Lessor for this Change Order requested by the Government.

**Paragraph Number 46** is hereby added to the Lease Contract as follows:

The Lessor shall provide all labor, materials, professional design fees and permits to furnish, install and maintain all changes identified in Tenant Work Request **Variance # 47, 56, 66, 69 and 70, in the Tenant Work Request (TWR)/Scope Variance Log.** The reference changes are to furnish and install as follows:

**TWR #47 – Add [REDACTED] locker units to Rooms S122 (15-81A) [17 ea.], 33-86 (A101) [3 ea.] Lockers to be DeBourgh First Responder Series 24" wide:**

Title to any and all alterations and tenant improvements for which the Government will make a "lump sum" payment shall vest in the government. The Government at any time can remove these items. The Lessor waives restoration in connection with these items. Unless the Government has removed the items from the premises, the Lessor shall remain responsible for maintenance and repair of all items provided by the Lessor under this lease. If after the lease term of any extensions, or succeeding lease term, the government elects to abandon these items in place, title shall pass to the Lessor.


All other terms and conditions of the lease shall remain in force and effect.
