<p><b>Paragraphs 36 and 37 are added.</b></p> <p>36. Upon completion and acceptance of Change Order 13-16 and 21-23 identified herein, the Lessor shall submit for Lump Sum payment, an original and one copy of the invoice. Lessor shall contact GSA Contracting Office for the "PS Number" which must be annotated on the invoice.
