Paragraphs 40, 41, and 42 are hereby incorporated into and made part of the lease.

"40. Alteration of Office Space: The Lessor shall provide all labor, materials and equipment to install the Above Standard Items as shown on Exhibit "G" Brookfield's January 24, 2012 quote for the elevator lobbies (floors 4, 5 and 6) and 6th floor feature wall signage. "42. Upon completion and acceptance of Tenant Improvements identified herein, the Lessor shall submit for Lump Sum Payment, an original and one copy of the invoice. The Original invoice, in the amount **not to exceed** \$9,322.28 shall be submitted to:
