NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective the date of Government execution, as follows:

Paragraphs 43, 44, and 45 are hereby incorporated into and made part of the lease.

"43. Alteration of Office Space: The Lessor shall provide all labor, materials and equipment to install the Above Standard Items as shown on Exhibit "H" Brookfield's January 25, 2012 quote for the following: 1) Modify partition walls at Hallway 611 to screen the access to Printer and Coffee areas. The scope of work involves removal of a section of

wing wall, construction of new partition walls, relocation of light switch and exit sign, painting, and minor repair of flooring materials as shown on the sketch proved by the [REDACTED]; 2) Install a door closure to Employee Lounge Room 424 to ensure this door will be closed at all times; and 3) Furnish and install backing at door hold on the south side of the 6th Floor Elevator Lobby. The Architect will pull the permit. The Architect's proposal includes an estimate of [REDACTED] for the permit fee and the Lessor has added a [REDACTED] allowance for any reimbursables. The Lessor's invoice to the Government will be based upon the actual architectural cost incurred.

This amount includes all construction management fees. Total cannot exceed \$15,208.00 without express written Government approval. The Lessor agrees to provide labor, material, and equipment to complete the additional Tenant Improvement to the lease premises as spelled out on Lessor's January 25, 2012 quote (Exhibit "H" to SLA No. 9). Such alterations should be completed no later than March 30, 2012."

"44. Upon completion, inspection, and acceptance of the space, the Government shall reimburse the Lessor in a Lump Sum Payment in the amount of \$15,208.00 pursuant to Paragraph 45, herein. The Lessor hereby waives restoration as a result of all improvements."

"45. Upon completion and acceptance of Tenant Improvements identified herein, the Lessor shall submit for Lump Sum Payment, an original and one copy of the invoice. The Original invoice, in the amount not to exceed \$15,208.00 shall be submitted to:
