WHEREAS, the parties hereto desire to amend the above Lease. NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution by the Government as follows:

Supplemental Lease Agreement (SLA) No. 2 is issued to document Notice to Proceed for Tenant Improvement Change Orders 3, 4, 8, 10, and 12 in the amount of **\$32,770.00**.

I. As recently negotiated, the Government approves the tenant improvement construction costs as follows:

- 3. Run 25 pair cabling from MPOE to Lan room
- 4. Changes between Bid Set vs. Construction Drawings
- 8. Install wall coverings at balance of area below the chair rail and add chair rail at wing walls and wall covering at the public side of the counters
- 10. Add additional plumbing cores for floor mounted toilets
- 12. Additional cost change of carpet tile in lieu of broadloom carpet









III. The Lessor hereby waives restoration as a result of all improvements. Unless the Government has removed such items from the premises, the Lessor shall repair and maintain such items provided by the Lessor in accordance with this Lease Agreement GS-09B-02682. If, after the lease term or any extensions, or succeeding lease term, the Government elects to abandon any items in place, title shall pass to the Lessor.
