NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective 4/30/2012 as follows:

Paragraph 2 of the SF2 is deleted in its entirety and replaced as follows:

1. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning May 21, 2012 and ending on May 20, 2032, subject to termination and renewal rights as may be hereinafter set forth.
