WHEREAS, the parties hereto desire to amend the above Lease to provide Change Order# 02 and order tenant improvements.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution, as follows:

- I. The Tenant Improvement Allowance is for \$904,471.35. In separate correspondence dated 3/14/2012, the Government issued a Notice to Proceed for Tenant Improvements in the amount of \$1,371,806.00. Previous change order total is for [REDACTED]. This Change Order #2 is for [REDACTED], which brings the total costs for tenant improvements to \$1,386,233.00. The tenant improvements exceed the Tenant Improvement Allowance by \$481,761.65. The Government hereby orders the balance of \$481,761.65. Notice is hereby given to proceed with the construction for tenant improvement in the amount not to exceed of \$1,386,233.00.
