WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective November 1, 2011, as follows:

**Paragraph 2** is deleted in its entirety and replaced as follows: TO HAVE AND TO HOLD the said premises with their appurtenances for the term of fifteen (15) years beginning on November 1, 2011 through October 31, 2026, subject to termination and renewal rights as may be hereafter set forth.

**Paragraph 3** is deleted in its entirety and replaced as follows:
