THIS AGREEMENT, made and entered into this date by and between: **Marina Lakes, LLC**

hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, as follows:

Paragraph 6 of the Lease is hereby modified to read In accordance with the SFO paragraph entitled Tenant Improvement rental adjustment, Tenant Improvements in the total amount of \$218,836.80 (6,500 USF x \$33.6672) are amortized through the rent for the first 5 years at the rate of 8%.

Paragraph 3 of the Lease is hereby deleted in its entirety and replaced to read The Government shall pay the Lessor annual rent of \$215,939.36.

Effective August 4, 2010, The Government shall pay the Lessor annual rent, monthly, in arrears, as follows:

For the purpose of paying the Government's portion of the Lessor's real estate taxes, the percentage of occupancy is established at 33.33%.

All other terms and conditions of the Lease shall remain in force and in effect.
