WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended, effective ~~MAR 02 1994~~, as follows:

1. The Lessor shall perform alterations in Building 12 of Corporate Square in accordance with the attached scope of work and floorplans. All alterations are to be completed no later than four (4) weeks after receipt of this fully executed Supplemental Lease Agreement.
2. The Lessor shall be reimbursed by Lump Sum payment for work performed in the total amount of \$30,246.00, after inspection and acceptance of the improvements by the Government and receipt of Lessor's itemized invoice. This dollar amount is subject to revision, as it is a function of acceptance of the actual quantity of those items at the negotiated prices for each. Payment will be made in accordance with the Prompt Payment Act.


"General Conditions For Lease Alterations" are attached hereto and made a part of this contract and specifically incorporated herein.


All other terms and conditions of the lease shall remain in force and effect.






