WHEREAS, the parties hereto desire to amend the above Lease to issue an Partial Notice to Proceed for Tenant Improvements

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon Government execution, as follows:

Paragraph 1: PARTIAL NOTICE TO PROCEED.


The Government has reviewed the budget dated October 27, 2011, and has elected to provide a Partial Notice to Proceed for Tenant Improvements. Of the \$2,110,368.00 total budget amount, the Partial Notice to Proceed shall not to exceed \$1,366,475.90, the amount of Tenant Improvement to be amortized into the rent pursuant to the lease. Upon further review and negotiations, the Lessor will receive another Supplemental Lease Agreement to approve the final negotiated amount that exceeds the Tenant Improvement Allowance.


The Government expects the Lessor to proceed with Tenant Improvement Construction pursuant to the approved scheduled for completion by March 30, 2012. The Lessor shall inform the Government of the expected date the Partial Notice to Proceed will be depleted. It is noted that the following items are not included in this Partial Notice to Proceed.


- Lobby Floor Finishes
- Draperies and Wood Blinds
- Any alternatives provided in the budget
- Any item specifically excluded in the budget
