**THIS AGREEMENT**, made and entered into this date by and between Waterfront A, LLC, Waterfront B, LLC, Waterfront C, LLC, Waterfront D, LLC, and Waterfront E, LLC, as tenants in common

whose address is 841 Bishop Street, Suite 1700  
Honolulu, HI 96813-4920

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

**WHEREAS**, the parties hereto desire to amend the above Lease

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said Lease is amended effective upon execution by the Governments as follows: Provide a "Notice to Proceed" (NTP) to Lessor for construction of costs as outlined in the attached exhibit. Based on Exhibit "A" (debits & credits), the costs for the lump sum items are broken down as described in the attachment and Paragraph 31 is hereby added.

31. In accordance with the above referenced contract, the Government is required to provide an NTP in order for the Lessor to commence construction of the change orders. This SLA shall serve as that NTP on the change orders requested.

Change Orders 24-42 in the amount of \$67,240.00

Per SLA 7 previously approved, a payment was issued for the C-Cure 9000 system and related items. As the amount was previously accounted for via SLA #5, the amount credited and applied to this lump sum payment is \$12,353.10.

The Government will provide a lump sum payment of **\$54,886.90** (\$67,240.00 - \$12,353.10) to Lessor upon satisfactory completion and acceptance of change order items. The Lessor shall submit for Lump Sum Payment, an original and one copy of the invoice for the reimbursable work items, including the annotation of PS Number "**PS 0018658**," on the invoice. The original invoice shall be remitted to:
