hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease to change ownership.

NOW THEREFORE, these parties for the considerations hereinafter mentioned covenant and agree that the said lease is amended, effective 6/7/2013, as follows:

Lease Amendment (LA) Number 15 has been prepared to memorialize the change in ownership through the Lease Assumption Agreement. Therefore, Paragraph 3 is deleted in its entirety and replaced with the same numbered paragraph in lieu thereof; and the following additions to Paragraph 7 are hereby added to the lease.

Paragraph 3. The Government shall pay the Lessor annual rent of \$134,319.78 at the rate of \$11,193.32 per month in arrears. Rent for a lesser period shall be prorated. Rent checks shall be made payable to:

\*The above rents are inclusive of accumulated operating expense adjustments as of 9/22/12. The next operating expense adjustment is due 9/22/13.

Use of the GSA Form 276, Supplemental Lease Agreement has been discontinued. All references in the lease to "GSA Form 276" or "Supplemental Lease Agreement" shall be now hereby construed to mean "Lease Amendment".

All other terms and conditions of the Lease shall remain in full force and effect.
