

US GOVERNMENT LEASE FOR REAL PROPERTY

THIS LEASE, made and entered into this date by and between AIRPORT DISTRIBUTION CENTER

Whose address is 250 S 5TH STREET 2ND FLOOR

and whose interest in the property hereinafter described is that of **OWNER**

hereinafter called the Lessor, and the **UNITED STATES OF AMERICA**, hereinafter called the Government:

WITNESSETH: The parties hereto for the considerations hereinafter mentioned, covenant and agree as follows:

1. The Lessor hereby leases to the Government the following described premises:

A total of 22,500 rentable square feet (RSF) of warehouse and related space, which yields 22,500 ANSI/BOMA Office Area (ABOA) square feet of space at Airport Distribution Center, 1175 Boeing Street, Boise, ID 83705-5436 to be used for such purposes as determined by the General Services Administration.

2. TO HAVE AND TO HOLD the said premises with their appurtenances for the term beginning on August 1, 2011 and continuing through July 31, 2021, subject to termination rights as may be hereinafter set forth.

3. The Government shall pay the Lessor annual rent according to the table below:

1-5	\$175,500.00*	\$26,775.00	\$202,275.00
6-10	\$183,633.75*	\$30,791.25**	\$214,425.00

*Shell rent is inclusive of taxes and building shell costs per the SFO.

**Operating costs are subject to adjustment per Paragraph 11 of this document.

Rent for a lesser period shall be prorated. Rent checks shall be made payable to:

4. The Government may terminate this lease in whole or in part at any time on or after July 31, 2016 by giving at least 120 days' notice in writing to the Lessor and no rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing.

12. In accordance with the SFO paragraph entitled *Common Area Factor*, the common area factor is established as 1.0 (22,500 RSF/22,500 ABOA Sq. Ft.).
13. In accordance with the SFO paragraph entitled *Adjustment for Vacant Premises*, the adjustment is established as \$0.00/ABOA Sq. Ft. for vacant space (rental reduction).
