PART I - SOLICITATION/DESCRIPTION OF REQUIREMENTS (To be completed by Government)

A. REQUIREMENTS

The Government of the United States of America is seeking to lease approximately 2,600 rentable square feet of office and related space and five (5) parking spaces located in Peoria, Illinois for occupancy not later than March 1st, 2011 (date) for a term of 10 years, 5 years firm. Rentable space must yield a minimum of 2,600 to a maximum of 2,600 square feet of ANSI/BOMA Office Area (ABOA) for use by Tenant for personnel, furnishing, and equipment.

B. STANDARD CONDITIONS AND REQUIREMENTS

4. The following standard conditions and requirements shall apply to any premises offered for lease to the UNITED STATES OF AMERICA (the GOVERNMENT):

- a. Space offered must be in a quality building of sound and substantial construction meeting the Government's requirements for the intended use.
- b. The Lessor shall provide floor plans for the offered space and a valid Certificate of Occupancy for the intended use of the Government and shall meet, maintain, and operate the building in conformance with all applicable current (as of the date of this solicitation) codes and ordinances. B. TERM

3. To have and to hold, for the term commencing on or about March 1, 2011 and continuing through February 28, 2021 inclusive. The Government may terminate this lease, in whole or in part, after five (5) years by giving sixty (60) days written notice to the Lessor. However, in the event that all commercial passenger airlines cease operations at this airport location, effectively eliminating the need for [REDACTED] presence, the Government shall have the right to cancel the lease with sixty (60) days written notice to Lessor at any time after the date of such cessation of service. No rental shall accrue after the effective date of termination. Said notice shall be computed commencing with the day after the date of mailing and no rental shall accrue after the effective date of termination.

C. RENTAL

4. Rent shall be payable in arrears and will be due on the first workday of each month. When the date for commencement of the lease falls after the 15th day of the month, the initial rental payment shall be due on the first workday of the second month following the commencement date. Rent for a period of less than a month shall be prorated.
