hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective June 29, 2010, as follows:

The intent of this Supplemental Lease Agreement No. 2 (SLA) is to authorize the lessor to perform cabling services within the premises located on the second floor of Indiana University Mauer School of Law, located at 211 S. Indiana Avenue, Bloomington, IN. The work shall include wiring 21 information outlets (I/O) using Mohawk CAT6e plenum rated cables at each outlet using Panduit 8 conductor jacks on each end. Both ends will be clearly labeled, and each port of the I/O shall be usable for voice or data. A Panduit Rack RU's with horizontal wire management will be provided. The rack is to be fastened to the wall at the top and secured to the floor at the bottom. All cable is to be home run in the suite to a patch panel in the storage room. Voice patch panels will be provided so that voice lines may be easily moved.

SLA No. 2 hereby gives notice to proceed with the cabling services set forth on the *UITS Telephone Services Prewire Estimate* attached to and made a part of this SLA at a cost of \$9,638.71. This cost includes all materials, labor during and after normal working hours, fees, drawings, permits and inspections, overhead and profit associated with this scope. Payment will be made in a lump sum after substantial completion and acceptance of the cabling services by the Government.

All other terms and conditions of the lease shall remain in force and effect.


