hereinafter called the Lessor, and the UNITED STATES OF AMERICA, hereinafter called the Government:

WHEREAS, the parties hereto desire to amend the above Lease.

NOW THEREFORE, these parties for the consideration hereinafter mentioned covenant and agree that the said Lease is amended, effective August 16, 2010, as follows:

The intent of Supplemental Lease Agreement No. 3 (SLA) is to modify the scope of tenant alterations to the 2nd floor, 211 S. Indiana Ave, Bloomington, IN, as shown on Construction Drawings dated 4/30/2010, Addendum #1 dated 5/16/2010, Addendum #2 dated 5/14/2010 and the Government's email of 5/18/2010, in reference to electronic ballasts (the "Construction Drawings").

SLA No. 3 amends the lease by adding the following to the Tenant Improvements:

CCD#1 Add additional layer of 5/8ths drywall Type X GWB to west wall of room 217A	\$230.21
CCD# 7 Ceiling Tile Changes in rooms 219, 208 A, B, C.	\$1,469.67

SLA No. 3 accepts the following changes to the design proposed by the lessor at no additional cost to the Government:

CCD# 2 Change ATT conduit from 1" to 2"
CCD# 3 Modify thresholds at door 217-A between corridor 219-J and Galley 219E
CCD# 4 5/8 fire rated drywall installation on south wall offices of 219C and 219D
CCD# 6 Amend mechanical design to provide return air plenum in Judge's chamber


These changes increase the cost of the Tenant Improvements from \$699,053.69 to \$700,753.57, which will be paid in a lump sum upon substantial completion and acceptance by the Government.

All other terms and conditions of the lease shall remain in force and effect.


