1. This Supplemental Lease Agreement shall be considered the Government's acceptance of the additional costs as listed below for the referenced change orders. Change order numbers 1, 2, & 4 – 14 are approved. The change orders are as follows:

CO #	Change Order Description
1	Tax on Doors. <i>*price was included in SLA #3</i>
2	Security Items (Kane Screening & Raceway Isolation).
3	Replacement of carpet with VCT 3 in room 6. <i>*Was part of lease requirement and not a change order item.</i>
4	Additional drywall layer.
5	Dielectric nipples to CPVC groove adapters.
6	Additional power panels and power feeds to be contained with-in room 18, also included in the pricing are requested changes for a light into a closet, changing the ballast for the light fixtures in room 6 and the rewiring of four relocated heat pumps due to secure wall locations.
7	Add man bars and Z duct not shown on drawings, based on field inspections by the [REDACTED]
8	Additional lights in the closets and for the lighting changes needed in the [REDACTED] restrooms/ shower rooms.
9	Additional architectural design fee for the Evidence Room countertop change.
10	The Agency has requested the door and frame to room 3-12 be removed and the wall in filled, open a doorway in the back of closet, 3-14, for entry into room 3-12 and the current passage set on the closet door be changed to a locking set.
11	Change in metal door hardware and seals per the attached breakdown and the additional work that is not included in the approved construction documents.
12	Additional fire alarm work.
13	Labor and material to complete framing, blocking drywall, laminate conter top and mahogany trim. Install half wood door with hardware. Supply 1 prefinished wood half door with veneered top, hinges and lever passage set.
14	Electrical work per the attached Drawing Review comments (6/13/11) & proposal by Power-Comm Electric Co., Inc. (7/5/11).

The costs include, but are not limited to, all materials, labor, overhead, profit, applicable sales tax, permitting and A/E fees. Upon receipt of a proper invoice from the Lessor, the Government shall reimburse the Lessor via a one-time lump sum payment in the amount of **\$79,500.95**.
